

Expression(s) of Interest (EOI) for membership on the Paediatric Eczema National Clinical Network Clinical Reference Group New Zealand Child and Youth Clinical Network Programme

The New Zealand Child and Youth Clinical Networks (NZCYCN) are keen to receive applications from people who work in Well Child Tamariki Ora settings within New Zealand to join the Eczema Clinical Reference Group (CRG) of the Eczema Clinical network. We are looking for a health care professional who has experience caring for whānau in community settings. In particular we would like someone with experience of caring for tamariki with eczema.

We have a focus on strengthening our equity lens. Therefore we will prioritise applicants who work predominantly within Māori and Pacific communities. If you work in a WCTO service and are interested in being a member of a group that provides national quality improvement for tamariki with eczema please send us an email with your interest.

The aim of all the CN's is to improve outcomes for tamariki, rangatahi in the context of their whānau. Further information on the programme can be accessed via the NZCYCN's website:

How do Networks work?

Clinical Networks receive funding and administrative support to work collaboratively to improve the delivery of services to whānau in a range of settings. Work plans are developed by the Clinical Reference Group (CRG). These are approved by the NZCYCN Governance Group with deliverables that have timeframes. This may include practice guidelines, whānau information, education for health professionals and a range of other activities that are based on best evidence.

CRG's include a multi-disciplinary team of people across a range of health settings; primary, secondary and tertiary and across a geographical range in Aotearoa New Zealand.

How often does the CRG meet?

The Clinical Reference Group meets approximately 4 times per year. This usually includes three short meetings by Zoom and one Face to Face day meeting; usually either in Wellington or Auckland.

The Terms of Reference for the CN provide an overview of governance and the responsibilities of the functions expected from the CRG. These are attached to this document. We recommend you discuss submitting your application with your manager so that you receive time to attend the Face to Face meetings. All transport costs and expenses associated with travel are funded.

Term of appointment

The term of the appointment currently is to the end of June 2022, as this aligns with our contract with the Ministry of Health.
